1. Introduction.

Health insurance premiums reflect the cost of health care in the markets we serve. While healthcare costs are projected to increase in 2024 in part due to regulatory mandates, taxes, and fees, Highmark New York has offset those costs for our members by employing a variety of strategies.

Our commitment to fully covering the cost of testing, treatment and telehealth for our members did not contribute the adjustment we are seeking. However, we did consider the potential impacts of services being postponed for our members.

Additionally, Highmark New York continues to focus on initiatives aimed at improving our members' health and reducing increases in underlying costs of the care our members receive.

While health care costs continue to rise, our efforts to create new ways of paying doctors and hospitals, manage prescription drug costs, and drive more effective care, helped to minimize the proposed rate increases for 2024.

2. Members affected.

This rate change application affects only the members enrolled in Medicare Supplement, community-rated group products. "Community-rated" means that all members with the same coverage have the same premium; premiums do not vary by age, sex, medical conditions, or health care services usage. Most other groups and government programs are subject to different premium-setting rules and a different approval process than those that apply to this application. The rate change will be effective January 1, 2024. Based on current membership numbers, we estimate that 69 members will be affected by the rate change.

3. Conclusion.

For all these reasons, we respectfully request a rate adjustment. Although we understand our customers' reluctance to have premiums increase, it is an unfortunate reality that our revenues must increase to meet our rising expenses, and we must maintain funds in our reserve account to protect our customers Proposed 2024 Medicare Supplement Rates:
